Re: **MOVEMENT OF PERSONS PERFORMING ESSENTIAL SERVICES**

1. We refer to the above matter.
2. We confirm that, during the lockdown period declared by the Minister of Cooperative Governance and Traditional Affairs on 25 March 2020, and as gazetted in Gazette number 43148, more specifically Regulation 11B(2)(3), persons performing essential services as determined, must be duly designated in writing by the head of the institution in a form that corresponds substantially with Form 1 in Annexure C in the Regulations.
3. We confirm therefore that, in terms of the Regulations, a person performing essential services only has to carry in his possession a form similar to Form 1 in Annexure C to the said Regulations, together with a form of identification as required by Form 1. This will normally take the format of a passport, identity document or driver's licence.
4. We confirm furthermore that no other documentation are required in terms of the Regulations as aforesaid.
5. Accordingly, it will be sufficient for a person performing essential services to merely carry the permit in accordance with Form 1, as well as a form of identification, during the lockdown period, and no further documents are required by the Regulations.
